Regular Meeting Minutes
Tuesday September 3rd, 2019 – 7 PM

Regular Meeting was called to order with the Pledge of Allegiance at 7:00 pm. Present: Brian Skroch, Bryan Anderson, Chris Scheel, Paula Kampa, and Julie Fandel, City Clerk.

- 1. Kampa made a motion to accept the agenda as presented for Tuesday September 3rd, 2019. Second by Anderson. Add Quit Deed to Business f. Kampa amended her motion to included quit deed. Anderson amended his second. 4 ayes 0 nays, motion carried.
- 2. Scheel made a motion to approve Consent Agenda as presented to include:

- e. Appoint City Council Member Kampa made a motion to offer the council member to candidate #2 if they don't accept #1, if they don't accept candidate #3, if they don't accept candidate #4. Second by Scheel. Skroch asked if this person would fill the same committees that Walter had. Scheel and Kampa stated that they think we will have to redo those again, depending on what the person wants to do. 4 ayes 0 nays, motion carried.
- f. Quit Deed Skroch explained that the property that McMeredith Development Inc. had committed to the city for park land had not been changed into the cites name. Anderson
