


#### City of Rice





Tuesday January 21st, 2020 - 7 PM

Regular Meeting was called to order with the Pledge of Allegiance at 7:00 pm. Present: Brian Skroch, Bryan Anderson, Chris Scheel, Paula Kampa, Emily Walters, and Julie Fandel City Clerk. Skroch opened the Public Hearing at 7:02. Skroch asked if anyone had and comments, none.

- 1. Scheel made a motion to accept the agenda as presented for Tuesday January 21st, 2020. Second by Anderson. 5 ayes 0 nays, motion carried.
- 2. Kampa made a motion to approve Consent Agenda as presented to include:

- d. Resolution #012120-03 Resolution Committing Street Funds. Scheel made a motion to approve Resolution #012120-03 Resolution Committing \$20,000 to the Street Funds. Second by Anderson. 5 ayes 0 nays, motion carried.
- e. Resolution #012120-06 Resolution Committing Funds to City Hall Equipment. Kampa made a motion to approve Resolution #012120-06 Resolution Committing Funds of \$13,997 to City Hall Equipment
- f. Resolution #012120-09 Resolution Committing Funds from Hasso Briese AM Legion #473. Scheel made a motion to approve Resolution #012120-09 Resolution Committing Funds of \$1,000.00 from Hasso Briese AM Legion #473 for the "Welcome to Rice Sign". Second by Anderson. 5 ayes 0 nays, motion carried.
- g. Resolution #012120-10 Resolution Committing Funds from Shepherd of the Pines. Kampa made a motion to approve Resolution #012120-10 Resolution Committing Funds of \$615.00 from Shepherd of the Pines for the "Welcome to Rice Sign". Second by Anderson. Fandel stated that she had contacted the attorney about having religion

represented on the sign and was told that it was fine, she will address it in the Clerks report. 5 ayes 0 nays, motion carried.

- h. Industrial Park Land Offer. Kampa made a motion to accept the offer from Prairie Farms for the purchase of the industrial land. Second by Scheel. Scheel stated the he had spoken to Anna at Prairie farms and that their intent was to use the land for farming at this time. Diana Wojtanowicz spoke and stated that that is correct however it could change in the future. Skroch stated that he had spoken to a few different committee members that stated we should try to get a business or factory that would generate more jobs. Kampa added that these lots are the last of the city industrial park. Wojtanowicz asked if the city would still be rent the property to Prairie Farms? Consensus of the Council was yes, and we would get the agreement ready for the February 3<sup>rd</sup>, 2020 meeting.
- i. Discuss/Approve RFP Civil Engineer. It was agreed that the council would do a paper ballot vote for the new Engineer. Fandel collected the ballots and read three votes for #3, two votes for #2. Scheel made a motion to approve the Engineering firm of Moore as the Cities Engineer. Second by Anderson. Kampa thanked all the Engineer candidates and stated that it was a very hard decision. 5 ayes 0 nays, motion carried.
- j. Graham Fire Contract Meeting February 11th, 8pm. Fandel stated that Graham Clerk reached out and that their supervisors would like to meet and go over the Fire Contract. Kampa, Skroch and Fandel will attend the meeting on February 11<sup>th</sup>, 2020 at 8 p.m. at the Graham Town Hall.
- k. Watab Fire Contract Meeting in April, 7pm. Fandel stated that Watab Supervisor Johnson reached out and that their supervisors would like to meet and go over the Fire Contract. Scheel, Skroch and Fandel will attend the meeting on April 7th, 2020 at 7 p.m. at the Watab Town Hall.
- 1. Increase Bremer ACH. Kampa made a motion to increase the Bremer ACH from \$11,000.00 to \$15,000.00 as per the letter request for the Rice City Treasurer. Second by Scheel. Skroch stated that he had contacted Lori Keller at Bremer bank and she stated that it had not been a problem with going over the limit, wasn't a problem to increase it. Keller also informed Skroch that the bank monitored if there were any over adjustments. 5 ayes 0 nays, motion carried.

Has the council decided on what they would like to do with the City Drum? Kampa asked if we should build a shelf for it in the chamber, Fandel will reach out to the Public Works and see if they will build one. I would like to attend the 2020 Safety and Loss Control Workshop on April 14<sup>th</sup>, 2020. It is held in St Cloud and the cost is \$20.00. I attended it last year and it was very informational. Consensus of the council was to attend.
