**Rice City Council Regular Meeting Minutes** Monday April 3rd, 2023, 6:00 PM

Mayor Brian Skroch called the meeting to order at 6:00 pm. Present: Paula Kampa, Ken Nodo, Michelle Keller, Chris Scheel, Steve Wollak, Public Works, Bobbi Caster, Office Assistant, and Julie Fandel, City Clerk.

Clerks Report - Thanks to Bobby and Steve for painting the stalls in the women's bathroom, what a difference. I received three bins for the plastic recycling program, one for City Hall and where would you like the other two? Kampa stated that the president of the Rice Chamber will reach out, she is going to see if we can rotate them between business. Skroch has already contacted both Hydrostat and PFG. Auto pay on utility bills is going well, we advertised that and cleanup day on the bills that just went out. Next Monday I will start selling compost stickers until the compost opens on April 25th, 2023. I will be completing my last year of Clerk Institution, I applied for a grant too. We did receive three of the four SCORE grants I applied for, the compost road was rejected, we may need to look at doing something with that. If you have any ideas for other grant requests, please let me know.

Public Works - Those are the tiles for the Lions building, Kampa asked if they will throw darts in them? Wollak said I can't answer that. Nodo stated that they look great and put them up! Wollak has been working to try to find cold patch for the potholes, no one has any in the state. He's going to have to buy bags for \$15.75. Consensus of the council is to keep filling them. We still have about \$17,000.00 in equipment behind the garage, what do you want done with it? Skroch asked Wollak to try and sell it. Wollak asked Kampa and Scheel what they meant when
