Rice City Council Regular Meeting Minutes Monday August 21st, 2023, 6:00 PM

Mayor Brian Skroch called the meeting to order at 6:00 pm. Present: Paula Kampa, Ken Nodo, Chris Scheel, Steve Wollak, and Julie Fandel, City Clerk. Absent Michelle Keller.

1. Public Hearing

b. Public Works - The 1998 lawn mower broke down and can't be fixed. I just wanted to get quotes so you can think about if you want to replace it this year or next. The quotes are from three locations, Arnie's here in town can't get the mower with suspension that we would like. Discussion on availability next spring, Nodo said fall is a better time to purchase, Wollak said that these quotes were from February, and they haven't changed as on 8-15-23. Scheel asked if there was any money from mowing lots this year, and there is not. Fandel believes that we have dollars in four areas for this. Kampa asked Fandel to check and email the council with the information. Skroch stated that he would like to move forward with it now, they are hard to get and may not be as available next spring. Kampa agreed noting that if we did have a lot of rain we would be out of luck. We have been working with the value in the water tower that is down in a hole, we thought we would have to have it fixed for about \$4,000. Bobby and I worked on it and finally got it loose and replaced the parts for about \$20. It was completely rusted together, probably the original. Scheel thanked Wollak for getting the soccer field back to green, looks great. Kampa stated that she also thanked Wollak vie text for getting 6th Ave done so quickly. Kampa asked Chief Hamann how the Summer Festival went. Hamann stated that overall, it was good, the parade was a little unprepared. He said that he talked to the neighbors that had issues last year and they were ok. The heat was the only real complaint. Kampa said she saw all the officers interacting with the crowds and thanked Hamann for all he did, the rest of the council did also.
