Rice City Council Regular Meeting Minutes Monday November 4th, 2024, 6:00 PM

- 2. Keller made a motion to approve Consent Agenda as presented to include:

- a. Notice of Benton County Board of Commissioners Public Hearing Ordinance #496 Regulating Cannabis – Kampa suggested that Fandel attended the Public Hearing. Fandel stated she would.
- b. Old Village Hall- Rice Sportsman It is getting increasingly difficult to hold their meeting at the OVH. They are wondering what the city's long-term plan for that building is. They may want to donate/partner with the city to help bring it up to a more useable space. Discussion on how to move forward, use this building or another one. Keller stated that the stage does not get used for anything. She also asked if the Boy scouts still used it, Fandel said yes. Kampa added that we could use another location to rent out. Nodo said it would be too expensive to take down so we should see if we can update it. The consensus was to get bids from an architect and a plan.
- c. Stantec Update projects, the Railroad approved the plan for the crossing, Fox's Meadows trail is complete, pay vouch should be coming in next week. Well – we will be scheduling a preconstruction meeting for the week of November 18-21, 2024. Lead Service line inventory is complete.

Kampa asked if Brian had started any of the training for his license yet, Bobby stated that he must work here for a year first.
