Regular Meeting Minutes
Monday April 21st, 2025

Mayor Skroch called the meeting to order. Present: Brian Skroch, Chris Scheel, Jacki Janski, Ken Nodo, Paula Kampa, Tim Grinstead, City Engineer, Jeremy Mathiasen, City Engineer, Bobby Vaillancourt, Public Works and Julie Fandel, City Clerk.

- 1. Scheel made a motion to accept the agenda. Second by Nodo. Skroch added/changed Business a. to 5th graders, b. Schlenner Wenner, c. Resolution, d. RFP Building inspector, e. Resolution and f. Stantec. Scheel amended his motion to include the changes. Nodo amended his second. 5 ayes 0 nays, motion carried.
- 2. Kampa made a motion to approve the Consent Agenda as presented to include:

 - b. Approve Board of Equalization Meeting Minutes April 14th, 2025. Second by Janski. 5 ayes 0 nays, motion carried.

4. BUSINESS

- a. 5th Graders- They are doing a project to enhance the city by putting up art that they have made around town. Kampa asked if it would be inside or outside, inside. Nodo asked if they would be doing the sidewalk chalk again this year, yes, they will. Kampa asked how many grades or just 5th? It would be anyone at school that wanted to. Skroch stated that it would be fine to put it in the City Hall, Scheel added and the Old Village Hall. Kampa complemented the two presenters, you are very brave and did a great job.
- b. Ashley Meagher Schlenner Wenner Meagher presented the 2024 audit. Kampa made a motion to accept the 2024 Audit. Second by Nodo. 5 ayes 0 nays, motion carried.
- c. RESOLUTION #042125-11 a Resolution Committing Funds from Rice Women of Today. Scheel made a motion to approve Resolution 042125-11 a Resolution Committing Funds from Rice Women of Today for the Welcome to Rice sign. Second by Janski. 5 ayes 0 nays, motion carried.
- d. RFP Building Inspector- Kampa made a motion to approve AllSpec Service as the Building Inspector for a three-year term. Second by Scheel. 5 ayes 0 nays, motion carried.
- e. RESOLUTION #042125-12 a Resolution for a donation to the Rice Police Department. Scheel made a motion to approve Resolution #042125-12 a Resolution for a donation to the Rice Police Department from the Royalton Dollar General. Second by Janski. Skroch asked Chief Hamann what the donation was? Hamann stated it was a wide variety of items shoes, decorations, books, dishes. 5 ayes 0 nays, motion carried.
- f. Stantec The test that Traut was doing for the city did not work, there was too much noise from houses and roads. We will need to re-evaluate what we want to do with the Well project, is the council ok with Stantec to explore other options? Discussion on where to move next and what options we have for a Well site. Unsure on cost if we need to treat nitrates and what options we have with the DNR. The consensus of the council was that we review and move forward. The railroad crossing is on track; we are still going back and forth with the plan. Mathiasen went over the road construction, Skroch stated he thought the prices looked good and we should consider doing more. Nodo stated that the engineer cost looked too high, Mathiasen, that is the percentage that most engineers use on projects. Skroch suggested adding more, then a smaller project next year and another larger one the following year, a three-year estimate. Discussion on what areas and how much to do. Kampa made a motion to have Stantec move forward with the resurfacing as follows: 3rd St NE looing to 1st Ave NE to 2nd St NE and 3rd Ave NE for the approximate cost of\$435,000.00 Second by Janski. 5 ayes 0 nays, motion carried.
